

**MID FLORIDA BUCKSKIN ASSOCIATION STALLION SERVICE AUCTION  
BID FORM/PURCHASE CONTRACT**

I \_\_\_\_\_, mare owner or agent, submit the following bid \$\_\_\_\_\_, for one stud fee from the stallion \_\_\_\_\_ . This fee is for the \_\_\_\_\_ breeding season. I hereby understand that if the Mid Florida Buckskin Association, hereinafter MFBA, accepts my bid, I will abide by all conditions as stated in this contract. Furthermore, I recognize that MFBA is only acting as agent for the sale of the stud fee and I do not have to be a member to submit a bid and enter into this contract.

**BIDS:**

All bids must include a non-refundable minimum payment/deposit of ½ the listed price to conform to the schedule below. All bids NOT ACCEPTED will be returned to the bidder. Separate deposits must be submitted for each stallion selected. Minimum bid is 50% of advertised price or \$500 if PT plus \$50 office fee.

**PAYMENT IN FULL:**

Payment in full, i.e., the full amount due on the sale of the breeding must be paid to MFBA before the bidder/purchaser's mare will be referred to the stallion owner. If for any reason full payment is not received within 45 days of the original bid submission and acceptance, ALL monies will be forfeited and the stallion breeding will be offered for auction again in the same breeding season. If payment is made directly to the stallion owner or representing agent, the owner/agent must forward all monies to MFBA before breeding the mare or the get WILL NOT be eligible.

**BREEDING SEASON:**

Breeding Season as defined by this contract is February 1 through June 15 of the year denoted above or as denoted in stallion breeder's contract.

**PROCESSING:**

Upon receipt of bid fee in full, MFBA will notify the stallion owner of the bidder's name, address and phone number. The mare owner may then breed to the stallion. **The mare owner may be required to sign a regular breeding contract if presented by the stallion owner or representing agent whereby the mare owner agrees to abide by all charges and conditions specified.**

**FEES:**

The bidder/mare owner agrees to pay a one-time \$50.00 service charge for each bid accepted by MFBA. **Additionally, the bidder/mare owner assumes all responsibility of all fees, but not limited to, board fees, vet fees, transportation costs, shipping costs that may be associated with the breeding of the mare to the selected stallion. Any discrepancies resulting from disputes between mare and stallion owners/agents will be resolved between the two owners/agents. MFBA will not mediate between disputes nor be held liable as a result thereof.**

**LIABILITY:**

The mare owner agrees that MFBA will not be held responsible for or assume any liability at any time in case of injury, accident or illness to mare and or foal of mare at any time.

**REFUNDS:**

NO REFUNDS-NO EXCEPTIONS

**ACCEPTANCE:**

I, the undersigned, do hereby agree to make all payments and abide by all the conditions stated and implied in the aforementioned agreement, including responsibilities in arranging for said breeding service with the stallion owner/agent.
